Cannot be employed by any school district, community college district, or office of education in the County of Santa Clara while serving on a school board.

SPECIAL DISTRICTS

General Qualifications: Must be 18 years of age or older, a U.S. citizen, a legal resident within the District(s), a registered voter, and not legally disqualified from holding an office.

◆**Additional Qualification:** Must continue to reside within the electoral district during his or her term of office, except that no change in boundaries of an electoral district shall affect the term of office of any incumbent director.

†**Additional Qualification:** Must be either an owner of land within the District or be designated by an owner of land within the District as their representative.

‡**Additional Qualification:** Must be a Veteran.

NOTICE IS FURTHER GIVEN that all active registered voters will automatically be mailed a Vote-by-Mail ballot package beginning on October 5, 2020; the Vote Centers for said election will be open starting on October 31, 2020, through November 2, 2020, for varying hours of operations. The Vote Centers will be open on Election Day, November 3, 2020, from 7:00 a.m. until 8:00 p.m. All ballots cast in said election will be counted centrally at the County of Santa Clara Registrar of Voters' Office, 1555 Berger Drive, Building #2, San José, California, 95112.
