The Independent Expenditure report is required only for committees (not candidate controlled) that make independent expenditures totaling \$1,000 or more to support or oppose a single ballot measure or a single candidate.

E- 82	Thursday, February 9, 2023	<b><u>RANDOMIZED ALPHABET DRAWING</u></b> This day the Secretary of State (SOS) and the local elections official will conduct a drawing of letters of the alphabet to determine the order in which candidates appear on the ballot.  <b>For local offices, candidates should refer to the SOS's drawing, and for State or Legislative offices, candidates should refer to the ROV's drawing for order of their name to appear on the ballot.</b>
